### What are the objectives of the club?

The Super 100 Heritage Club is run primarily to raise funds for Dacorum Heritage Trust to safeguard the collections.

### How does the club works?

Just buy one or more tickets (numbers) and they will be entered into each monthly draw. Prize draws will take place in the week ending the 2<sup>nd</sup> Friday in each month. A generous 35% of the money will be allocated to the prizes. The more tickets we sell the bigger the prize money! Winner's cheques will be posted after each draw. Renewal reminders will be sent when due.

### Who can join the club?

Anyone over 18 years can join, so please keep a copy of this information and give it to friends, family, neighbours and work mates.

### How many numbers can I have, and how much does it cost?

You can own as many tickets as you like - £12 per ticket per year. The more tickets you have, the better your chances of being a winner! You can pay by cheque (made payable to 'Dacorum Heritage Trust Ltd'), cash or fill in a Standing Order form attached (which we would prefer) or available from our website ([www.dacorumheritage.org.uk](http://www.dacorumheritage.org.uk)). On receipt of your completed application form and payment, you will be sent a membership ticket showing the number(s) which have been issued, together with a full set of rules and a confirmation letter.
